This notice is for members who are considering retiring with the LRO or WPC offers.

When considering your options for accepting either one of the offers, members should direct certain questions to the pensions group, Employment Insurance (EI) and/or your financial advisor.

If you are younger than age 55, you should ask the pensions group what effect retiring before reaching age 55 will have on your pension. Also, you should ask your financial advisor what effect retiring before age 55 will have on your CPP.

Any member retiring with either one of these offers should also check with EI before you retire to see if you will be eligible to receive EI benefits. If you are eligible, confirm any timelines that need to be adhered to under EI.
